# Spreading Holiday Cheer

Through our annual Christmas Cookout fundraisers and Angel Trees initiative, we were able to make a meaningful difference for families and children across our service area. Thanks to our communities, we were able to make a significant impact across our service area:

Agricultural Tax Exemptions - In order to claim an exemption from Texas sales and use taxes on electricity and other items used in agricultural and timber operations, you are required to provide us with a registration number on Texas Agriculture Sales and Use Tax Exemption Certification Form 01-924. All water wells should be exempt if used for irrigation or watering livestock. The Texas Comptroller's Office issues the registration number and those wanting to claim the exemption must fill out an application. Registration numbers must be renewed every four years. Applicants can request a paper application to mail in by calling 1-800-252-5555 or download a copy from the comptroller's website, <u>www.getreadytexas.org</u>. The generic exemption certificate, Form 01-339, cannot be used to claim the agricultural exemption. Accounts that do not have the new required form on file will be subject to taxation. **Commercial Tax Exemption Records** - A completed and signed exemption form is required for each commercial tax exempt account. Accounts that do not have current exemptions on file will be changed to taxable accounts. Any refunds for taxes must be claimed from the State of Texas. Thank you for your help.

# SYSTEM MAINTENANCE CONTINUES

Starting in January, we will continue our maintenance program with pole changeouts on Wetzel Feeder 2. This phase covers areas southwest of Roby, including FM 419, Claytonville, and towards Rotan, such as the Fisher County Hospital.

#### What to Remember:

- Brief outages may occur during maintenance.
- Crews will notify residents before any outages.
- We aim to minimize disruptions and complete the project quickly.

We appreciate your understanding as we work to enhance the reliability of our service.

# Enjoy Continued Savings with PCA Credit

The 3¢ PCA (Power Cost Adjustment) credit will continue into January, bringing you additional savings on your electric bills. This credit is due to a significant decrease in the cost of purchased power in 2024.

The PCA is a rate component on your electric bills that reflects the fluctuating costs of purchased power from our provider, Golden Spread Electric Cooperative. Our average expected purchased power cost is \$0.06 per kWh. The PCA adjusts for the difference between this budgeted cost and the actual market price of electricity, ensuring fair and transparent billing.

A 3¢ credit translates to roughly a \$60 savings for an average usage of 2,000 kWh. We are grateful to be able to give back to our members, especially during a season when expenses are higher as many of us are recovering from the holidays.

Unlike investor-owned utilities, our savings go back to our members, not to profits. We strive to support and uplift our members by providing affordable and reliable energy. Our financial team works diligently to forecast and budget for costs, aiming to mitigate swings in purchased power prices and ensure stable billing.

We are dedicated to transparency and open communication. If you have any questions or need further clarification about the PCA or any other aspect of your bill, please do not hesitate to reach out. We're here to help!
