5. Make a list of essentials and store them all in one location.

6. If you plan a non-mandatory evacuation, shut off natural gas, propane or fuel supplies before leaving.

7. Pay attention to air quality alerts.

8. Wait for local authorities' approval before returning home.

## Golden Spread EC Gives Back to Local VFDs

Big Country EC and the Community Involvement Committee (CIC) of Golden Spread Electric Cooperative, Inc. are giving back to local communities with a donation of \$9,120 to 16 volunteer fire departments, including the Anson Volunteer Fire Department.

Arron Duniven, Field Engineering Coordinator with BCEC presented the donation to Lieutenant Robert Patterson, Captain Clyde Patterson, and Firefighter Bryce Basham at the Anson VFD firehouse.

"At Golden Spread Electric Cooperative, prioritizing the wellbeing of our Members' and their communities is paramount," Brennan Umsted, CIC Chairperson, said. "We believe that few organizations embody this commitment as well as our local volunteer fire departments."

The Anson VFD is currently raising funds to purchase extrication and fire department maintenance battery operated tools.

The volunteer fire departments receiving donations this year are Anson, Balko Fire & Rescue, Bovina, Burkett, City of Howardwick, East Concho, Eldorado, Gruver, Happy, Hawley, Hedley, Morton, New Deal, O'Donnell, Texline and Whiteface.

"The men and women who serve on volunteer fire departments across our 16 Member service territories selflessly donate their time, talents, and resources to ensure that our communities are safe," Umsted said. "I'm proud to be a part of a cooperative that prioritizes this kind of community investment," said Umsted.

BCEC is a Member of Golden Spread, a generation and transmission organization with a total of 16 Member cooperatives. Golden Spread purchases and supplies power to Big Country Electric Cooperative for its member-consumers and follows one of the Seven Cooperative Principles, Concern for Community.

The Golden Spread Board of Directors entrusts to the CIC an annual budget, which is used to benefit the territories served by its 16 Members. Activities and organizations are selected by the CIC and supported by Golden Spread employees. Additionally, over \$15,000 in employee donations support volunteer fire departments and senior nutrition programs in its Members' service territories throughout the year.

Agricultural Tax Exemptions - In order to claim an exemption from Texas sales and use taxes on electricity and other items used in agricultural and timber operations, you are required to provide us with a registration number on Texas Agriculture Sales and Use Tax Exemption Certification Form 01-924. All water wells should be exempt if used for irrigation or watering livestock. The Texas Comptroller's Office issues the registration number and those wanting to claim the exemption must fill out an application. Registration numbers must be renewed every four years. Applicants can request a paper application to mail in by calling 1-800-252-5555 or download a copy from the comptroller's website, <u>wwwgetreadytexas.org</u>. The generic exemption certificate, Form 01-339, cannot be used to claim the agricultural exemption. Accounts that do not have the new required form on file will be subject to taxation. **Commercial Tax Exemption Records** - A completed and signed exemption form is required for each commercial tax exempt account. Accounts that do not have current exemptions on file will be changed to taxable accounts. Any refunds for taxes must be claimed from the State of Texas. Thank you for your help.

## Capital Credits Update: Your Piece of the Cooperative Pie

As a member of Big Country Electric Cooperative (BCEC), you're part of a unique organization where community and cooperation form the backbone of operations. One of the distinctive benefits of being a cooperative member is the allocation of capital credits.

Capital credits represent the margins or profits earned by BCEC in excess of operating expenses. Unlike investor-owned utilities, where profits go to shareholders, electric cooperatives like BCEC operate on a not-for-profit basis. This means that any excess revenue, after covering expenses, is allocated back to the cooperative's members in the form of capital credits.

The allocation of capital credits is typically based on the amount of electricity a member purchases from BCEC. The more electricity you use, the larger your allocation of capital credits is likely to be. At BCEC, the FIFO/LIFO (first in, first out/last in, first out) method has been chosen by the board of directors to ensure that both longterm and new cooperative members benefit from membership.

Once capital credits are allocated to members, they are retained by BCEC as equity capital to help finance infrastructure improvements, maintenance, and other capital expenditures. This reinvestment strengthens the cooperative and ensures reliable service for all members.

Each year, the cooperative's board of directors determine the portion of the allocated capital that may be retired and returned to members. In March, the board voted to retire 20% of the 2023 assignable margins, totaling \$1,781,672. 80% of the total will be applied to outstanding capital credits retirements for 1993, 1994, and a portion of 1995, while 20% will be applied to 2023.

2023 Capital Credits Allocation Notices were mailed to members in late April. Retirement checks for eligible accounts in the abovementioned years will be mailed by the end of this month.

Capital credits exemplify Cooperative Principle #3: Members' Economic Participation. At BCEC, all cooperative members invest in their cooperative, ensuring that people, not shareholders, benefit from the co-op's profits.
